Important remarks prior to filling this form

Attention to some religious and legal aspects that should be considered:

- 1. This form is not valid unless completed and signed.
- 2. A copy of the identification card for each party signing must be attached.
- 3. A copy of previous marriage or divorce documents must be attached.
- 4. If one or both parties hold dual citizenship, a copy should be attached.
- 5. A consent is required for a virgin female by her parent guardian either through his presence or by presenting an official consent from him, unless she can submit proof that negates the necessity of his consent.
- 6. The applicant must not be associated with a valid legal marriage.
- 7. There is no fee for conducting the marriage contract or issuing the religious marriage certificate, however gifts or charitable donations are accepted.
- 8. Any information provided by the applicant in this form will not be disclosed without their consent, unless disclosure becomes religiously or legally necessary.

Major rights of spouses (husband and wife) according Islam:

- 1. Both parties by matrimonial contract are entitled to sexual intercourse, except in justifiable excuses.
- 2. Both parties by matrimonial contract are entitled to kind treatment, respect and good conduct.
- 3. By matrimonial contract the wife is entitled to suitable means of living that fits her social status, including: housing, food, clothing, and health.
- 4. By matrimonial contract the husband is entitled to compliance, obedience, coordination and permission to leave the marital home, since the husband is obliged by Islam to manage the family and preserve its sanctity.
